**SUBJECT:** Letter of Clarification

RE: Elevator-Esclator Maintenance and Repair Services RFP

TO: All Prospective Proposers

Houston First Corporation ("HFC") issues this Letter of Clarification regarding the Elevator-Escalator Maintenance and Repair Services RFP to answer questions timely received and clarify the certain portions of the Elevator-Esclator Equipment Exhibit in the manner set forth below:

## **QUESTIONS AND ANSWERS**

**Question 1**: Is HFC exempt from sales tax?

Answer: Yes. The Contractor cannot submit invoices including state sales and use tax.

**Question 2**: Are parts billable under the contract?

<u>Answer</u>: Please refer to Section 3.5 of the agreement. Parts affixed to units are to be reimbursed to the Contractor at cost. Prior approval is required if a part will cost over \$25,000, or if the sum of all parts for a facility is expected to exceed \$50,000.

**Question 3**: Are reports submitted online or hand delivered?

Answer: Reports to General Managers may be submitted by email.

Question 4: What are the penalties for a unit being out of service for an extended period?

<u>Answer</u>: HFC has elected not to include liquidated damages as part of the contract for these services, although the Contractor is responsible for prompt performance and liable for their negligent acts and ommissions.
