- 1. Public Comments. None
- 2. <u>Minutes.</u> Following a motion duly seconded, the minutes of the October 16, 2017 and February 22, 2018 meetings were approved as presented.

 - A. Event Security Plan and Protocol.
- 4. Consideration and possible recommendation of the 2018 Partnerships and Event Development Plan. Michael Heckman provided the background on the Partnerships and Event Development commission plan, including the employees included in the plan, the percentages based on event renewal and the tiered commission structure. Brenda Bazan stated that the revenues are audited by an internal audit group. Following discussion on this item, a motion was made and duly seconded to recommend the 2018 Partnerships and Event Development Plan to the Benefits & Compensation Committee for review and approval.
