This Letter of Clarification is issued as part of the referenced project solicitation for the purpose of revising the revising the Project Engineer's estimates with regard to the size and quantity of drainpipe to be removed and replaced. The overall total has increased from 931.5 linear feet to 1,689 feet, as itemized below and as reflected on the revised drawings.

  - b. part 3 EXECUTION- 1. 7 INSTALLATION- A: shall be revised to state: 'Where the replacement pipe serves a fixture (lav, sink, water closet, etc. on the floor above) - replacement stops at 8" below the slab above; pipes within or above the slab are not replaced.
  - c. part 3 EXECUTION- 1. 7 INSTALLATION- B: shall be revised to state: "Where the replacement pipes serve a floor drain or floor sink in the floor above, scope includes replacement of the pipe and the P- trap, but <u>not</u> the drain body or the tailpiece between drain body outlet and top of the P trap section"
  - d. part 3 EXECUTION- 1. 7 INSTALLATION-D: shall be revised to state: "No trap primer valves or water lines connected to traps are being replaced. Traps currently having primers shall be reconnected to the existing water line."
