

PRICING FORM OPERATIONS AND MAINTENANCE SERVICES RFP

("Proposer"), as an integral part of its Proposal in response to that certain RFP for Operations and Maintenance Services issued by Houston First Corporation ("HFC") on January 17, 2020, offers to provide comprehensive operation, maintenance and repair services at its facilities based on the following fees, upon which Proposer represents that HFC can rely without exception:

§1. Management Fee

Propose a Management Fee for the Services. As stated in the RFP, such fee must be inclusive of all amounts due and payable for the Services other than Labor Rates, Reimbursable Expenses, and Task Orders (e.g., administrative costs or fees, overhead, finance and accounting services of any kind or type, processing fees, insurance, rent, office supplies, office furniture and equipment, personnel training, personnel certification/licenses, travel, testing, background checks, permits, attorneys' fees, litigation expenses, transportation, vehicles, parking, fuel, and applicable taxes).

The Management Fee will be allocated, in accordance with the RFP, among the Facilities based on the following percentages: (a) George R. Brown Convention Center 38%; (b) Gus. S. Wortham Theater Center 18%; (c) Jesse H. Jones Hall for the Performing Arts 12%; (d) Miller Outdoor Theatre 5%; (e) TBH 3%; (f) Partnership Tower 9%; (g) Parking Facilities 7% (Theater), 5% (Avenida District); (h) Outdoor Properties/Fountains/Tunnels/Miscellaneous Properties (3%).
