The Theater District and Convention District Operations Committee ("Committee") of Houston First Corporation (the "Corporation" or "HFC"), a Texas local corporation created and organized by the City of Houston as a local government corporation pursuant to TEX. TRANSP. CODE ANN. §431.101 et seq. and TEX LOC. GOV'T. CODE ANN. §394.001 et seq., posted a meeting at Partnership Tower, 701 Avenida de las Americas, Harris County, Texas, 77010, on Thursday, December 20, 2018, commencing at 1:00 p.m.

The meeting was called to order at 1:07 p.m. and a quorum was established.

Public Comments. Josh Gilbert, General Manager of Grotto, provided an update on the restaurant. Grotto has increased banquet traffic by 18% since last year resulting from a number of events held in December. Sales increased over the last year with increased business in the downtown area. Mr. Gilbert stated that his team has worked hard to bring in outside business and expects 2019 sales will be even better.

Frank Wilson asked about the marketing efforts of the restaurant. Mr. Gilbert explained that Grotto has a dedicated banquet coordinator that engages with outside groups to host events at the restaurant.

The Committee Chair thanked Mr. Gilbert for his presentation.
